PROGRAM OVERVIEW

Breast cancer is the most common cancer and the second leading cause of cancer deaths among women in the United States. The goal of this conference is to provide primary care providers from various backgrounds with important updates about breast cancer that can be incorporated into their practice. The conference aims to help bridge the rapidly widening gap between primary care and the latest knowledge about breast cancer risk factors, current screening methods and guidelines, state-of-the-art multimodal treatment, and issues related to survivorship and quality of life.

TARGET AUDIENCE

Primary care physicians, internists, family medicine practitioners, hospitalists, physician assistants, nurse practitioners, nurses, residents, fellows, and medical students will benefit from this course.

EDUCATIONAL OBJECTIVES

At the conclusion of this activity, the participant should be able to:

- Discuss benign breast disease with increased risk for breast cancer
- Discuss risk factors for breast cancer and current screening methods and guidelines
